## TERMS AND CONDITIONS

### Karen Carr Travel Consultants and Seattle Chamber Music Society

Karen Carr Travel Consultants has organized this tour to Charleston sponsored by the Seattle Chamber Music Society.

#### Reservations

The deposit of \$1000.00 per person is required to hold a reservation. Deposits are due by November 1, 2011. Reservations are accepted in the order of receipt. Wait list reservations will also be processed in order of receipt. **The full balance is due February 24, 2012. A minimum of 20 participants is required.**

#### Cancellation Policy

In the event of a participant's written cancellation up to 180 days prior to the departure, the deposit shall be refunded minus an administration fee of \$500.00. Cancellations received by Karen Carr Travel Consultants 180 - 120 days of departure will result in the loss of the deposit. There will be no refund of unrecoverable costs for any cancellations received less than 120 days before the start of the tour. After the tour has commenced, it is not possible to issue any refunds. Unused services during the tour cannot be refunded. **TRIP CANCELLATION INSURANCE IS STRONGLY RECOMMENDED.**

In the case of a cancellation due to shortage of participants or other unforeseeable circumstances, Karen Carr Travel Consultants will notify all participants at least 30 days prior to departure. In such case, full refund of the cost of the tour shall constitute full settlement with the passenger. In exceptional, unforeseen circumstances Karen Carr Travel Consultants reserves the right to postpone the tour to a later date.

#### Participation

We ask that participants consider their health to insure that they are able to participate in scheduled activities. Karen Carr Travel Consultants and Seattle Chamber Music Society bear no responsibility for medical problems, or for any medical costs of a participant. All medical evacuation costs are the participant's responsibility.

Persons who must leave the tour after it commences will receive no refund for unused services.

#### Itinerary

Every effort will be made to adhere to the printed itinerary. However, circumstances beyond the control of Karen Carr Travel Consultants and Seattle Chamber Music Society may force changes or substitutions. Karen Carr Travel Consultants reserves the right to make any alterations to the itinerary for the benefit of the tour.
